

Greetings from SUN-DAC

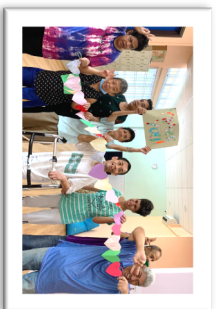
Established in 1990, SUN-DAC was the first void deck Day Activity Centre in the community. We are a non-profit social service agency that serves and cares for persons with disabilities. We currently have about 140 clients in 3 centres.

Unlike many other Day Activity Centres, SUN-DAC takes in mostly persons with moderate to severe disabilities. Many of our clients and caregivers are also from low income families, who without assistance may have to stay at home.
